Agri Tourism

Consultant, Chris Doozan, reviewed the proposed revisions to the Zoning Ordinance to add regulations for Agri Tourism. Chris reviewed the definition of Agricultural Tourism, standards under which this would be allowed, added more detailed parking, what is considered minor and major, regulations for overnight accommodations, and hours. Major operations would require a special use permit, while minor would be by right.
