Agri-tourism

Consultant Chris Doozan reviewed the revisions that are based on the discussion held at the November 19th meeting and discussion with the Supervisor.

Noted are the following revisions:

- Signage would need to meet the guidelines in the Zoning Ordinance.
- Minor Operations hours would be until 8:00 p.m. Major Operations hours would be at the discretion of the Planning Commission.
- All four Minor Criteria would need to be met to be considered a minor operation.
- Exclusions: Any place a particular use is already regulated in the Zoning Ordinance is excluded along with any use that is superseded by GAAMPS.
- 13: Examples of Agri-Tourism were added.
- Removed Agri-Tourism from the RE district.
- Discussion:
- Removal of the RE district was to insure balance of the right of neighbors and the use of property.

Commissioner Weston moved to call for a Public Hearing to consider amendments to the Zoning Ordinance for Agri-Tourism to be held March 18, 2015.
