# **Road Improvements**

**Roads 2009 –10 budget**—The Road Committee met with representatives from the ICRC. The Township has budgeted \$30,000 and the ICRC will match this for a total of \$60,000. The recommendation for expenditure is: Baan Gan Aka Subdivision (\$40,315); Oakleaf Hills Subdivision (\$11,000) leaving a balance of \$8,865.

**SHERIFF PATROL** A Town Hall Meeting was held on June 17,2009 to inform residents of the County Commissioners plan to eliminate road patrol and the impact it will have on the community.

#### Grants:

A Transportation Enhancement Grant will provide matching funds from the state to construct 8' paved shoulders along both sides of M-43 for non-motorized transportation between Meridian Rd. and Zimmer Rd. The project will be paired with a project to resurface M-43 and will include signs and pavement markings to increase the safety of bicyclists. The project cost is \$450,000, including \$292,500 in federal TE-funds and \$157,500 in match from Williamstown Township.

Secondly, Williamstown Township in cooperation with Leroy Township, Locke Township and Wheatfield Township were awarded \$75,384 through an Energy Efficiency and Conservation Block Grant as part of the American Recovery and Reinvestment Act of 2009. These funds will be used in part to conduct audits on Township owned facilities, to reduce energy consumption and demonstrate LED & energy lighting, to amend the Williamstown Township Master Plan and Zoning Ordinance to increase and promote non-motorized and public transportation and LEED standards for new construction, to add a bus stop at the Williamstown Township Park, to increase and promote public transportation and to increase awareness and involvement of residents in energy conservation, recycling and resource conservation through light bulb exchanges, seminars, publications and demonstration projects.
