

2021 MARCH BOARD OF REVIEW MEETING SCHEDULE

Williamstown Township, Ingham County

The Williamstown Township Board of Review for March 2021 will be held by **electronic remote access due to the ongoing issues associated with the COVID-19 epidemic and relevant guidance issued from MDHHS**, unless by the dates of the March Board of Review meetings it becomes lawful under state agency rules for an indoor in-person public meeting to be held. Electronic remote access, in accordance with Michigan law, will be implemented in response to COVID-19 social distancing requirements and limitations on the number of individuals in an indoor public gathering.

If in-person public meetings become a lawful option, then the meeting will be held **both** in person at the Williamstown Township Hall, 4990 Zimmer Rd. Williamston, MI **and** via **electronic remote access**.

- Monday, March 15, 2021, 9:00 am – 12:00 pm = **Appeal Hearing**

The Board of Review will meet as many more days as deemed necessary to hear questions, protests, and to equalize the 2021 assessments. By board resolution, taxpayers are able to protest by letter, (*including email*), sent to 4990 Zimmer Rd. Williamston, MI 48895 or bloomquistw@williamstowntownship.com, provided protest is received prior to 11:00 am March 15, 2021.
