# Police Protection

In the last three years the Ingham County Commissioners have drastically reduced the budget of the Ingham County Sheriff's Department. Over the last two years the out county Townships of Ingham County have been in discussions with the county commissioners and the sheriff's department attempting to change their directions of cuts. We appealed to their sense of commitment to the residents that personal safety was a top priority.

Unfortunately, at this time, the Ingham County Commissioners have voted to eliminate all out county police services as of January 1, 2011.

The safety and security of Ingham County citizens is and always has been our highest priority. With the Ingham County Commissioner's intention to eliminate coverage the twelve (12) out county Townships and one Village listed below have each passed a resolution to place on the November ballot the question of raising money to fund police services for their residents:

Alaiedon, Aurelius, Bunker Hill, Ingham, Leroy, Leslie, Locke, Onondaga, Stockbridge, Vevay, White Oak, Williamstown and the Village of Dansville.

While no one wants to raise taxes, we are proposing a yearly maximum amount of \$150 or \$12.50 per month for a residential unit and \$250 for a commercial or industrial unit.

If the ballot question passes, the Townships and the Village will form a police board and provide police services for all the residents collectively. The unification of Ingham County Townships over the issue of public safety is unprecedented. We are all working together to provide the best service to the residents of rural Ingham County.

The Townships and the Village will work from now until the November election to inform our residents on this critical issue.

# Property Tax Information

PLEASE TAKE NOTICE that Summer property taxes are due every year on September 14. The Treasury Department will be open from 9:00 to 5:00 (extended hours) on Tuesday, September 14 to take tax payments. Regular office hours are 10:00 to 4:00 on Tuesday, Thursday, and Friday and 1:00 to 7:00 on Wednesday. The office is closed on Mondays.

There are **FOUR** different ways you may pay your property taxes:

- 1. **Township Hall** Summer taxes may be paid with cash or check at the township office.
- 2. **By Mail** Send your check and payment stub by mail to the township office. Please note that tax payments need to actually arrive in the office in order to be processed **postmarks cannot be accepted as a payment date**.
- 3. **Drop-off Box** Leave your payment in the bronze drop slot beneath the bulletin board by the front entry of the township hall, only if payment is made by check, and the stub from the bottom of the tax bill is included with the check. Residents should not leave cash in the drop slot.
- 4. \*NEW\* At Independent Bank Cash or check payments may now be made at Independent Bank (1245 E. Grand River location ONLY). You MUST HAVE YOUR PAYMENT STUB in order to pay your bill at Independent Bank. Payments for summer taxes WILL NOT be accepted at Independent Bank after September 14th.

Payments that are in the drop box or Township mailbox **before the start of business** on Wednesday, September 15 will be considered to have arrived on <u>September 14</u>. All taxpayers who pay by mail or in the drop slot will receive an official property tax receipt by return mail, **ONLY** if they have requested one by checking the box on their tax stub.



# Cemetery News

If you haven't yet seen the completed columbarium it is worth a drive through the cemetery to see it at the crest of the hill. A dedication is planned for later this summer. The columbarium is unique to this area and is meant to address the increasing demand for interment of cremated remains. Burial niches are available for purchase by non-residents as well as residents of our community. Although the cost for non-residents is somewhat higher, it is still very competitive with comparative costs in other areas.

The township website now offers access to a lot of information about the cemetery, including individual burial records. Part of the record includes the specific burial plot for an individual which can be located on a schematic diagram of the cemetery. To access this information just go to the township website and under departments listed click on "cemetery" and then click on "cemetery register" just above the photo.

Cemetery rules and regulations are also available on the website. It is important that everyone be aware of these and adhere to them since it makes mowing and trimming safer and overall maintenance more efficient.
